## Proposed changes to our Heritage Overlay (Amendment C147)

Maribyrnong City Council proposes changes to the planning controls for specific types of works on homes and properties that are currently located in Heritage Overlay areas across our City.

Current planning controls require owners to apply for permits for external works and alterations. In some instances, these works have little to no impact on the heritage value of a place but still require planning approval.

A range of minor works have been identified that should be exempt from the planning process, and these works are outlined in our proposed Amendment C147. For example: converting rear windows to French doors would no longer require a planning permit under the Heritage Overlay precincts.

Amendment C147 seeks to change the Heritage Overlay under the Maribyrnong Planning Scheme.

## How will this affect heritage places?

These works are generally not visible from the street and would not impact on the heritage significant and appearance of a place.



# The amendment does not apply to the following heritage building and places

If your property has been identified as 'individually significant' in the Maribyrnong Planning Scheme or on the Victorian Heritage Register, these proposed changes do not apply, and you will require planning approval.




