Recommendations to improve the quality, efficiency, and performance of Council's maintenance and cleaning of Footscray CBD.

Following the Cleansing Service Review, a number of changes are proposed to the service. These changes are aimed at providing a more effective and efficient service which would adequately address the community's concerns and provide value for money.

Short Term Improvements (3 months)

1. Level of Service

A number of changes are proposed to the level of service as summarised in Tables 1.6 and 1.7.
